**Introduction** There were 44 members present including executive members. Cliff Weir handed the chair to Don Bain, the Zone G-2 Commander, who ran the annual election of new Branch 92 officers.

Cliff Weir requested that the newly elected executive meet at 7 pm on Tue 24 May.

**1<sup>st</sup> Vice President** Ron Miller thanked Carl Duff, Glen Parker, Peter Mills, and Wes Rideout for their work over the past year doing the monthly bar stock audits.

**Treasurer** Bill Beswetherick noted that the Branch Building Fund has \$28,511.67 and the General Fund account has \$68,009.94 for a total of \$96,521.61 that can be used for maintenance and operations. He also reminded members of the high cost of maintaining the building. Utility costs alone for the past two months were \$2,596. We also paid \$1,971 in taxes but at the end of the year we receive most of these taxes back except for the school taxes. Even snow removal can be expensive. Our most recent bill for clearing the parking lot was \$845.

**Lottery** The Lottery Fund has \$4,992.82. Bill Beswetherick proposed that the Branch sponsor four tables at \$50 each at the Gananoque Intermediate and Secondary School Fundraising Spring Fling. This would allow the Branch to include on the tables information about the Gananoque Legion. Bill stated that he would donate copies each of the books *Voices from the Past*, *Canadian Letters from the First World War* and *Gananoque Remembers* for the silent auction fund raiser.

There was discussion about a request from the Playhouse Theatre for funds to purchase an Automated External Defibrillator (AED) at a cost of \$2,000 plus taxes. It was decided that the Theatre should be capable of purchasing the item on its own.

**Poppy** Bill Beswetherick noted that the Poppy Fund will be sponsoring a Veteran's Dinner at Carveth on Wed 8 Jun.

There was discussion about whether to make a donation towards the Fort McMurray Disaster Relief programme organization. Dominion Command has allowed Branches to donate up to 50 percent of their poppy fund to the disaster relief plan. It was noted that funds can come from General Revenue as well as from Branch Raffle Funds. After some discussion, it was decided to wait to assess the situation before making a decision on a donation.

**Sick and Visiting** Bev Miller noted the Christmas party that was held at Carveth for veterans and Legionnaires. She provided Alfie Read and Mike MacDonald with comforts.

**Honours and Awards** Alfie Read noted that there will be a meeting of the Honours and Awards Committee at 10:00 am in Wed 18 May.

**House and Property** Cliff Weir noted that the new gas stove would cost about \$6,500, which is considerably less than the initial estimate of \$8,000. He also noted that the old stove should fetch about \$250 as scrap metal.

Cliff then gave Manager Ann DeWolfe a cheque for \$2,000 which represents the most recent metal collection that he and Carl Duff and John Robertson have made in the Metal Reclamation Programme.

**Manager** Ann DeWolfe noted that Super Friday 29 Apr with a meat draw and a fish fry was a great success. She said that two bartenders are off sick but that a new bartender has been acquired.

**New Business** Zone G-2 Commander Don Bain briefed members on Zone G-2 and District G happenings. Branches are allowed to use Poppy Funds for the INVICTUS games which feature injured and sick service personnel. Don indicated that there will be an effort to raise per capita by \$1. He also noted that efforts are underway so that small branches do not have to pay for the testing of their water. There also was a concern that higher electricity rates will have on the viability of small branches.

**Branch Adjournment** At 8:20 Ron Knapton made a motion to adjourn. Seconded by Owen Fitzgerald. Carried.
